## **Membership Incentive to Recruit and Sign up Members.**

The member's name that is on the application for membership will receive the incentive.

Regular and Unmarried Memberships earn a \$100 credit for 2016 dues. If the new member rejoins in 2016 the member gets a \$100 credit in 2017, and if the new member renews again in 2017 the member gets a final \$100 credit in 2018.

Junior and Out of County Memberships earn a \$50 credit for 2016 dues, and the same in 2017 and 2018 as long as the new member continues their membership. If the junior or out of county have a membership change to Unmarried or Regular in 2016 or 2017 the recruiting member will receive \$100 credit for their dues in the year following.
