KIRKSVILLE COUNTRY CLUB-MEMBERSHIP CLASSIFICATIONS

- A. **FAMILY MEMBERSHIP:** This membership includes the use of all facilities and participation in all activities of the Club. The family membership has one vote. For purposes of the Policy Manual, "family membership" shall be defined as follows:
 - (1) Married couples or unmarried partners residing in the same household, and their natural and/or adoptive children 23 years of age or younger, who reside in the same household or whose primary residence is that of the parents.
- B. **UNMARRIED MEMBERSHIP:** Any unmarried individual may participate in this class of membership. It includes the entire use of the facilities and participating in all Club activities. Each membership has one vote. This is a single membership.
- C. **JUNIOR MEMBERSHIP:** This membership has all the privileges of the Family Membership. On January 1st following a 29th birthday, a Junior Membership must change to another type of membership. No member of this membership may have a spouse that is above the age of 29. This is a family membership.
- D. **STUDENT MEMBERSHIP:** This is a membership for full-time students or the spouse of a full-time student. It includes all of the privileges of an unmarried membership, with the exception of the voting privileges. The applicant shall be required to provide the Club with confirmation that they are enrolled in an institution of higher education or vocational school and enrolled in at least 9 hours of accredited courses per semester.
- E. **OUT-OF-COUNTY MEMBERSHIP:** A family or unmarried membership for people living outside of Adair County. It includes the use of all facilities and participation in all events of the Club. This is a voting membership. This is a family membership.
- F. **SOCIAL AND POOL MEMBERSHIP:** A family membership for people desiring to only use the pool or attend the social activities of the club. This is a voting membership.
- G. **STUDENT MEMBERSHIP THROUGH HIGH SCHOOL-** A single membership for students to use the facilities of the club. This membership is available to students that are in school and terminates on December 31 following the student's graduation from high school. If this membership is used for entry into the Kirksville Country Club pool the individual must reach the age of 11 by June 1 of the current year. This membership allows no guest or babysitter privileges. This is a non-voting membership.

PAYMENT PLANS

- 1. **FULL PAYMENT** of total due.
- 2. **3-PAYMENT PLAN.** Divide the balance due by 3. Pay 1/3 at the time of joining and make 2 equal payments. The final payment is due by July 1.
- 3. **MONTHLY PAYMENT PLAN.** A preauthorized payment plan can be established with your bank. The amount of the withdrawal is indicated by the membership plan on the front of this document. The Office Manager will provide the necessary forms.
- 4. **CREDIT CARD.** A 3% convenience fee will be added to all membership plans paid via credit card.
